- ✓ APPLICATIONS FOR THE TALENT SHOW MUST BE TURNED IN NO LATER THAN JULY 15th.
- ✓ PARENT SIGNITURES ARE REQUIRED FOR EVERY CONTESTANT UNDER THE AGE OF 18 YEARS OF AGE.

All contestants must be signed in at 3:00 pm, or they will be cut from the show.
There will be no exceptions

There will be four age divisions; 6 and under, 7 through 9, 10 through 13, and 14 through 21. In each age group, there will be a musical and a Dance category. The 6 and under group will open up the show. They will be awarded their trophies immediately following their group. Next, the 7- 9 age groups will perform, followed by the 10–13, and finally the 14-21 age group. Once these three groups are finished performing, they will return to the stage for the award ceremony. There will be a first, second, and third place trophy awarded in each age division for both categories (Music and Dance). In addition there will be a grand prize trophy awarded to the music and dance categories with the highest points scored over all.

If your act includes a band or you are bringing in musical instruments or any stage props you will have the opportunity to drive into the fair and unload your equipment if you make prior arrangements with Cindy Hawkes at 459-8901, or 237 -1626.. She will open the gate up at 12:00 for bands and or props to be dropped off inside the fair grounds. Cars will be allowed in on a first come basis. We will only allow two cars in the gate at one time. We will close the gates at 3:00 pm, no one will be allowed in to unload after this time, no exceptions. You will need to unload as fast as possible and then you will be asked to move your vehicle out side of the fair grounds. All drum sets may be set up at the back of the

stage, behind the trophy display. All other instruments must be put into the safe room, which will have a security person present at all times. Participates will be allowed to stay in once their equipment is dropped off, however they must turn in their entrance ticket, and everyone who entered through the gate in the vehicle will be asked to leave and re-enter through the fair gate.

Once your equipment is set up we will give you the opportunity (on a first come basis) to speak with the music technician about your instruments microphones and anything else you will need from them to play your music. This includes testing your instruments for proper sound; however, you will only be given 15 minutes for this, unless no one else is waiting behind you. This opportunity is only available until 3:00 pm. If you are bringing in a lot of equipment, we suggest you arrive as soon as possible, again you are required to be signed in by 3:00 and your equipment must be set up by 3:00 no exceptions.
